

Privacy Policy

This Privacy Policy governs the manner in which ID Group Inc. collects, uses, maintains and discloses information collected from users (each, a "User") of the <https://www.idgroupinc.com/> website ("Site"). This privacy policy applies to the Site and all products and services offered by ID Group Inc.

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our site, subscribe to the newsletter, and in connection with other activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, email address. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Non-personal identification information

Web browser cookies

How we use collected information

We may use third party service providers to help us operate our business and the Site or administer activities on our behalf, such as sending out newsletters or surveys. We may share your information with these third parties for those limited purposes provided that you have given us your permission.
